INSTRUCTIONS

This kit is designed to help you nominate a candidate for the Claire L. Felbinger Award for Diversity and Inclusion.

Before you send in your nomination, make sure to:

1. Read the Criteria carefully and ensure that your nominee has the distinguished qualities to be eligible for this Award.
2. Review the nomination and letters of reference to ensure they are within the stated word limits. Nominations that do not adhere to word limits will not be reviewed.
3. Complete and sign the Nomination Form.
4. Email the completed nomination in PDF format to awards@abet.org by April 20 and keep a copy for your records. No handwritten entries will be accepted.

Deadline: April 20

Nominations are accepted year round, but must be received by email before our April 20 deadline. No exceptions will be granted.

Renominations of past winners will not be accepted.

Expect a written notification of receipt from ABET Headquarters. If you do not receive confirmation, please send an email to awards@abet.org.

By the end of September, you should expect notification on the outcome, following formal vote by the ABET Board of Delegates.

Claire L. Felbinger Award for Diversity and Inclusion

The Claire L. Felbinger Award for Diversity and Inclusion is presented to recognize educational units, individuals, associations and firms for extraordinary success in achieving greater diversity and inclusion in the technological segments of our society.

The recipient(s) will receive a \$10,000 award.

THE CRITERIA

ELIGIBILITY

Persons involved in the current year's Claire L. Felbinger Award for Diversity and Inclusion (Felbinger) evaluation and selection process (e.g., Members of the Awards Committee and Felbinger Subcommittee) are not eligible to be nominated, nominate or provide a reference for the Felbinger Award.

SELECTION CRITERIA

A maximum of 2 candidates (1 individual and 1 program/institution/organization) are presented annually to our Board of Delegates by the Awards Committee.

To be chosen for the Claire L. Felbinger Award for Diversity and Inclusion, your nominee will be judged against these criteria:

1. CAUSE

The nominee has a clear and targeted mission to advance diversity and inclusion in technical education or the technical fields.

2. IMPACT

This initiative has proven success in achieving greater diversity and inclusion in technical education or the technical fields.

3. COMMITMENT

The nominee has dedicated years toward achieving their goals and has an obvious desire to continue their work.

4. LEGACY

The method and results that this initiative have produced can be translated across disciplines and demographics to affect larger change for years to come.

5. DISSEMINATION OR TRANSPORTABILITY

DISSEMINATION (for nominations of individuals):

The broad distribution of these achievements informs the efforts of others.

OR

TRANSPORTABILITY (for nominations of programs):

The ability of this program to be transferred to other persons and entities.

Claire L. Felbinger

As a Public Member on our Board of Delegates from 1998 to 2004, Claire L. Felbinger was a driving force for inclusion and led the first committee to formally bring the issue of diversity to the attention of the Board.

She was a tireless advocate for efforts to promote diversity and set in motion the work that is still being done today. Under her leadership, the Public Member Committee launched initiatives to consider and publish ABET Expert diversity statistics, issue a formal policy on diversity, and the creation of the President's Award for Diversity in 2005.

Dr. Felbinger passed away suddenly in her home on May 28, 2008. To honor her legacy, the award that she helped create now bears her name.
