### INSTRUCTIONS

This kit is designed to help you nominate a peer for the Linton E. Grinter Distinguished Service Award.

Before you send in your nomination, make sure to:

- **1.** Read the Criteria carefully and ensure that your nominee has the distinguished qualities to be eligible for this Award.
- 2. Request ABET volunteer history. If you would like this information for your nominee, please email <a href="mailto:awards@abet.org">awards@abet.org</a> by April 1.
- 3. Contact several persons to determine if they would be willing and are eligible to serve as a reference. These letters of reference should attest to their knowledge of the candidate's contributions and the significance of these contributions.
- 4. Complete and sign the Nomination Form.
- 5. Send a copy of the completed Nomination Form to each of the selected references.
- **6.** Email the completed nomination in PDF format to awards@abet.org by April 20 and keep a copy for your records. Handwritten entries will not be accepted.

#### Deadline: April 20

Nominations are accepted year round, but the Nomination Form and the references considered in a given annual cycle must be received by email before our April 20 deadline. No exceptions will be granted.

Expect a written notification of receipt from ABET Headquarters. If you do not receive confirmation, please send an email to <a href="mailto:awards@abet.org">awards@abet.org</a>.

By the end of September, you should expect notification on the outcome, following formal vote by the ABET Board of Delegates.

## Linton E. Grinter Distinguished Service Award

The Linton E. Grinter Distinguished Service Award honors an individual whose rare commitment and enduring impact has made ABET a better organization.

For this reason, a Grinter Award recipient may not be chosen every year, only when the discernable influence of one ABET Expert's tenure warrants singular recognition. Their achievements are not year-to-year, they span decades and have shaped the course of our work.

The award is our highest honor and the contributions of its recipients define our organization.

### THE CRITERIA

#### **ELIGIBILITY**

Persons involved in the current year's Linton E. Grinter Distinguished Service Award (Grinter) evaluation and selection process (e.g., Members of the Awards Committee and Grinter Subcommittee) are not eligible to be nominated, nominate or provide a reference for the Grinter Award.

#### **SELECTION CRITERIA**

To be chosen for the Linton E. Grinter Distinguished Service Award, your nominee will be judged against these criteria:

#### 1. STRATEGIC VISION

A leader that has used expert insight and keen foresight to guide our organization into the future.

#### 2. LASTING COMMITMENT

Genuinely dedicated to our organization and the work that we do, this individual has devoted decades to promoting our causes.

#### 3. DIRECT CONTRIBUTION

The accomplishments of this individual have been focused on the direct success of ABET.

#### 4. BROAD ENGAGEMENT

This ABET Expert has had a significant impact at multiple levels of our organization including (but not limited to):

- a. Program Evaluator
- b. Accreditation Commission Member
- c. Standing or Special Committee Member
- d. Elected Official

#### **SELECTING REFERENCES**

There is no specific minimum or maximum on the number of references. However, quality of the recommendation, diversity of the references and stature of the references in terms of their knowledge and experience with ABET are more important than quantity. References should comment specifically on the accomplishments of the nominee against at least one aspect of the selection criteria.

To be chosen for the Linton E. Grinter Distinguished Service Award, your nominee will be judged against the following criteria: **Strategic Vision, Lasting Commitment, Direct Contribution and Broad Engagement.** In-depth descriptions for each category can be found on page 5.

#### **REFERENCES**

Reference letters should expand upon and/or introduce additional strengths. Ask each of your references to answer the following question with a two-page maximum response.

On the basis of the work of the candidate, which you are competent to judge, please indicate whether or not the candidate meets the requirements for the Linton E. Grinter Distinguished Service Award. What distinguishes this contribution from the norm?

Your letter of recommendation should be two pages maximum and sent to the nominator on your official masthead. If you do not have a masthead, please submit a word document in the form of letter.

### Linton E. Grinter

In 1972, Dr. Linton E. Grinter received the first Distinguished Service Award from ABET's predecessor, the Engineer's Council for Professional Development (ECPD). To convey the lasting impact that his achievements would have, the award was immediately renamed in his honor.

Dr. Grinter was an outstanding leader, as a member of ECPD and as an academic. Among his many achievements, he chaired the committees that produced three reports that have had major effects on engineering education: (1) the 1945 Manual of Graduate Study in Engineering; (2) the groundbreaking 1955 Report of the Committee on Evaluation of Engineering Education, now known as "The Grinter Report" —a major work in the development of engineering curricula that outlines specific objectives for both the technical and humanities areas of study necessary for future engineers; and (3) the 1972 Report on Engineering Technology Education.

His professional career spanned over 50 years and included many awards and honors from his peers. From 1963-1967, Dr. Grinter served as Vice President and President of the ECPD. His powerful insight into the future of the engineering profession was not merely felt by the ECPD and the engineering education of his time; his enduring legacy continues to shape our work throughout technical education and across the globe.

Recipients of the Linton E. Grinter Distinguished Service Award are ABET Experts who follow in Grinter's footsteps, surpassing the highest expectations of effort and commitment. It is our organization's highest honor.

## **SELECTION PROCESS**

The President of ABET annually appoints a special committee for review of nominations for this award. The Awards Committee's recommendations are presented to the members of the Board of Delegates for concurrence.

The award is presented at ABET's Annual Awards Celebration. In addition, the individual is recognized in the ABET Annual Report and on the ABET website.

Members of the ABET Awards Committee or Grinter Award Subcommittee are **ineligible** to serve as nominators or references for Grinter Award candidates. However, unsuccessful candidates may be re-nominated for consideration in a subsequent year.

Current or former members of ABET staff are eligible to receive the Grinter Award, but only based on contributions made in a volunteer role.
